

## **Privacy Policy for Skey Network**

At Skey Network, accessible from <https://skey.network> one of our main priorities is the privacy of our visitors. This Privacy Policy document contains types of information that is collected and recorded by Skey Network and how we use it.

If you have additional questions or require more information about our Privacy Policy, do not hesitate to contact us.

This Privacy Policy applies only to our online activities and is valid for visitors to our website and users of services with regards to the information that they shared and/or collect in Skey Network. This policy is not applicable to any information collected offline or via channels other than this website.

### **Consent**

By using our website, you hereby consent to each purpose of data collection and to our Privacy Policy and agree to its terms.

### **Information we collect**

We limit the scope of all requested and processed data to the necessary minimum, and we use the data (this also includes personal data, if the user provides it):

- a) In order to enable the user to set up a personalized account as part of the Application and to operate it, as well as to use the Service. The user provides us with the data necessary for this purpose and gives us consent to process it for this purpose (such data are the blockchain address, name and description),
- b) In order to provide the Application user with the possibility of using the Service, we use the user's location, the history of activities performed as part of the Service,
- c) In order to provide the Website user with the possibility of using the Service, we use the user's location, the history of activities carried out as part of the Service,
- d) In order to send the user of the Application commercial and marketing information, as well as sending a newsletter or information about product availability, the user may provide an e-mail address, giving us consent to deliver them.

We do not make automated decision-making and profiling based on the personal data of the Service user.

The personal information that you are asked to provide, and the reasons why you are asked to provide it, will be made clear to you at the point we ask you to provide your personal information.

If you contact us directly, we may receive additional information about you such as your name, email address, phone number, the contents of the message and/or attachments you may send us, and any other information you may choose to provide.

When you register for an Account, we may ask for your contact information, including items such as name, company name, address, email address, and telephone number.

## How we use your information

We use the information we collect in various ways, including to:

- Provide, operate, and maintain our website
- Improve, personalize, and expand our website
- Understand and analyze how you use our website
- Develop new products, services, features, and functionality
- Communicate with you, either directly or through one of our partners, including for customer service, to provide you with updates and other information relating to the website, and for marketing and promotional purposes
- Send you emails
- Find and prevent fraud.

## **Log Files**

Skey Network follows a standard procedure of using log files. These files log visitors when they visit websites. All hosting companies do this and a part of hosting services' analytics. The information collected by log files include internet protocol (IP) addresses, browser type, Internet Service Provider (ISP), date and time stamp, referring/exit pages, and possibly the number of clicks. These are not linked to any information that is personally identifiable. The purpose of the information is for analyzing trends, administering the site, tracking users' movement on the website, and gathering demographic information.

## **Cookies**

Like any other website, Skey Network uses 'cookies'. These cookies are used to store information including visitors' preferences, and the pages on the website that the visitor accessed or visited. The information is used to optimize the users' experience by customizing our web page content based on visitors' browser type and/or other information.

We use necessary cookies to make our site work. We'd also like to set analytics cookies that help us make improvements by measuring how you use the site. These will be set only if you accept. Necessary cookies enable core functionality such as security, network management, and accessibility. You may disable these by changing your browser settings, but this may affect how the website functions.

We'd like to set Google Analytics cookies to help us improve our website by collecting and reporting information on how you use it. The cookies collect information in a way that does not directly identify anyone.

## **Advertising Partners Privacy Policies**

You may consult this list to find the Privacy Policy for each of the advertising partners of Skey Network. Third-party ad servers or ad networks use technologies like cookies, JavaScript, that are used in their respective advertisements and links that appear on Skey Network, which are sent directly to users' browser. They automatically receive your IP address when this occurs. ### **GDPR Data Protection Rights**

The right to restrict processing – You have the right to request that we restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to our processing of your personal data, under certain conditions.

The right to data portability – You have the right to request that we transfer the data that we have collected to another organization, or directly to you, under certain conditions.
