## WEBSITE TERMS AND CONDITIONS v 3.0

### I. Definitions

The terms used in the Website Terms and Conditions have the following meanings:

1. Terms and Conditions - a set of general rules described in this document, constituting the legal basis for the use of the Website, the provisions of which shall apply if nothing else follows from the content of specific regulations concerning particular Electronic Services or sub-services available on the Website.
2. Skey Network UAB/Website Administrator Skey Network UAB based in Lithuania, Vilnius 08104, Lvovo g. 105A, registry code 306081745.
3. Website - organized IT and information platform connected to the Internet, created by Skey Network, enabling Users to use prepared IT mechanisms and information developed by Skey Network or its partners, as well as other global Internet resources and to perform commercial operations via the Internet. The Website may also be referred to by equivalent terms such as Website (online) <https://skey.network>, Hub (online) <https://skey.network>, Portal (online) <https://skey.network>.
4. User - means any person who uses the Website in any way.
5. Electronic Services - means services provided electronically by Skey Network or other entities, based on contracts with Skey Network.
6. Information Services - content provided at the individual request of a User (by displaying a page with a specific URL address) concerning any of the subpages of the Website. The subject of information services is information contained in the resources of the Website, including in particular short reports on current events, original materials from the Website and press materials.
7. Cookies - information saved by the <https://skey.network> server on the User's computer that can be read each time the computer connects to the Website.

### II. General Terms

1. Each User is obliged, upon commencing to use the Website, to comply with the Terms and Conditions.
2. Skey Network, in cooperation with various partners, may provide Users with multiple subservices where Users can use the services provided by Skey Network or its partners. In the case of subservices, the Terms and Conditions shall apply to Skey Network services, unless the content of the specific regulations regarding the given Electronic Service provided by Skey Network otherwise provides. The provisions of specific regulations, made available by partners under individual subservices, apply to the services provided by partners.
3. In the event of discrepancies between the content of the Terms and Conditions and specific regulations, in matters relating to individual Electronic Services or subservices, the provisions of specific regulations regarding these services or subservices shall apply in the first place.
4. Detailed regulations regarding individual Electronic Services or subservices are made available by Skey Network or the entity providing the given services, on the websites enabling the use of these services.

5. We may revise these list of services or subservices from time to time to better reflect new regulatory requirements once they occur or improvements or enhancements made to our services or subservices provided by our partners.

6. If an update affects your use of current services or your legal rights as a user of our services, we'll notify you prior to the update's effective date by sending an email to the email address associated with your account or via an in-product notification. These updated terms will be effective no less than 30 days from when we notify you. If you don't agree to the updates we make, please cancel your account and stop using the Services before the updated Terms become effective

### III. Conditions for concluding and terminating contracts for the provision of electronic services

1. The contract for the provision of Information Services is concluded at the moment when the User types in the appropriate Internet address in the web browser, the website of his choice containing the content provided on the Website or uses redirection to such Website. The contract is terminated when the User leaves the Website. Conclusion and termination of agreements for the provision of other services provided by Skey Network shall be subject to the provisions of the detailed regulations referred to above, available on the websites enabling the use of those services.

### IV. Responsibility for using the Website

1. Skey Network reserves the right to unilaterally decide on the content of the Website, make changes to it, without having to notify Users of its intentions. The User ensures that he will use the Website, both in terms of receiving and sending information, only in a manner consistent with applicable law, principles of social coexistence and morality, with respect for intellectual property rights.

2. Skey Network reserves that it is not responsible for whether use of the Website, meets the expectations of the User, as to the substantive content, accuracy, or usefulness of the information obtained, unless such warranty is expressly formulated in any document signed by Skey Network.

3. To the fullest extent permitted by law, Skey Network is not responsible for the consequences of the use by the User of the information obtained through the Website, in particular for the consequences of financial management decisions made on the basis thereof.

4. Skey Network reserves the right to cease providing or modifying the Website.

### V. Intellectual Property Rights

1. Skey Network, offering Users access to information disseminated through the Website, pays special attention to the need to respect intellectual property rights.

2. Website Users are obliged to use any of the content presented solely in terms of fair use. Copying, altering, transmitting, publicly reproducing, and any use of this content without permission from Skey Network for commercial purposes is prohibited. By using the works, Users do not acquire any rights in them, including but not limited to obtaining a license.

3. It is forbidden to use the resources and functions of the Website in order to carry out commercial activities by the User or activities which would infringe the interest of the Website Administrator.
4. Users ensure that any use they make of the materials via the Website, including copying, transmitting and making them publicly available on the Internet, is done with permission of the authorized entities. Users shall be liable for any damage resulting from their behaviour contrary to the above provision.
5. Any use other than as permitted under paragraph 3 may only be made with the prior written consent of Website Administrator.
6. Use for purposes other than authorized personal use, including for business or professional purposes, requires the prior written consent of Skey Network.
7. Use for purposes other than the permitted personal use, including for business or professional purposes without the required prior written consent of Skey Network, is subject to a license fee of EUR 20,000.00 per case.
8. The User pays the fee by bank transfer to the bank account indicated by Skey Network.
9. Skey Network will issue a provisional invoice for prepayment or a deferred payment invoice (in the case referred to in paragraph 8). Skey Network will provide the invoice to the User electronically via email.

## VI. Privacy Policy

1. Skey Network assures that it will use its best efforts to guarantee due protection for all information provided so as to make the use of the Website safe for Users.
2. Portal uses Cookies only to collect information related to site traffic statistics, e.g. for Google Analytics, Youtube.

## VII. Additional Terms

1. Skey Network reserves the right to unilaterally make changes to the Terms and Conditions. Changes will be published on an ongoing basis in the form of a consolidated text of the Terms and Conditions and shall become effective after 7 days from the date of their publication on the Website.
